- No news on Govt decisions on OPDC Outline Business Case
- OPDC 2024/5 proposed budget proceeding through Assembly scrutiny sessions with no comment to date.

Table misses out response from Andy Slaughter MP questioning purpose and role of the SPD.

Extract from Mayor's report to Assembly Dec 21st

Old Oak Common Station: On 23 November, OPDC's Board met with representatives from HS2 and DfT and visited Old Oak Common Station. Board members were reassured that the operational delivery of Old Oak Common station remains on course, which will support the phased delivery of the comprehensive regeneration of Old Oak. OPDC is working closely with all key stakeholders, including HS2, DfT, DLUHC, the boroughs and TfL on key outstanding issues which include eastern access and Elizabeth Line capacity as a result of Old Oak Common becoming a temporary HS2 terminus station.



HS2 plans for 2024/5

HS2 Ltd will let around 5 billion GBP worth of contracts to build the railway's tracks, power systems, signalling, overhead lines and a new network control centre.


Rail Minister Huw Merriman MP set up an 'Old Oak Task Force' last October with DfT, HS2, OPDC, and TfL. GUA (JC) pursuing details via Fol.

HS2 latest 2024 'project update' is on YouTube. Images of OOC station box and Victoria Road crossover box. Avoids reference to cancellation of line north of Birmingham. No news on Euston.






HS2 station Eastern Access Road Second road access to £1.7-billion station

OPDC Planning Committee on December was cancelled. HS2 application for temporary buildings east of OOC station may be on Jan 25th agenda.


Atlas Wharf proposals now have GLA Stage 2 decision, allowing final consent to be granted by OPDC.

2 Portal Way, likely to be at OPDC Planning Committee early 2024 Holiday Inn 4 Portal Way, revised proposals are at pre-app stage. Meeting with developers yet to happen.

OONF again questioning Imperial powers to build 1 Portal Way.
